RESOLUTION
#R-20-011

This matter came before the Tillamook County Board of Commissioners on May 5, 2020. The Board of Commissioners, being fully apprised of the records and files herein, finds as follows:

1. Under the emergency powers granted by ORS 401.305, on March 14, 2020 the Board of Commissioners signed Resolution #R-20-005 designating a State of Emergency within Tillamook County due to the spread of the Coronavirus (COVID-19).
2. On March 22, 2020 the Board of Commissioners signed Resolution #20-006 continuing the emergency and closing within Tillamook County all county, state, and federal parks, all county parking lots, beach access, and certain parking areas along road rights-of-way, and all county public boat launches to non-commercial users.
3. On April 22, 2020 the Board of Commissioners signed Resolution #20-008 continuing the emergency through May 15, 2020.
4. Although the emergency still exists, the Board deems it is appropriate to begin a safe and strategic reopening of county facilities.

NOW, THEREFORE, LET IT BE RESOLVED, that following are effective immediately:

5. The Tillamook County boat launches located at **Nehalem Bay, Memaloose Point, Netarts Bay, and Pacific City (off Sunset Avenue)** shall be open on the following dates for access only by users with a valid Tillamook County Annual Parking Pass or Day Use Pass.
 - a. May 6-7; May 12-14; and May 18-22.
 - b. The boat launches will be closed at 5:00 p.m. on May 7, May 14, and May 22.
6. All commercial and non-commercial boat launch users shall adhere to the following regulations. Failure of user compliance will result in closure.
 - a. No guests other than immediate family members.

- b. No more than two (2) occupants per boat.
 - c. Only one (1) boat on a boat launch at a time (i.e. no access on the launch until the previous boat leaves the launch).
 - d. Adhere to the Governor's order on physical distancing in parking lots, boat launches, and boats, which requires always maintaining a distance of six (6) feet.
 - e. Facemasks are always recommended while outside of a vehicle and in between boat launching.
 - f. Be self-sufficient. Carry needed supplies with you (soap, hand sanitizer, toilet paper, food, etc.) to minimize non-essential stops. Wash your hands frequently.
 - g. Go right from your house to the boat launch and back. No unnecessary contact with anyone.
7. All other county public boat launches remain closed to non-commercial users.
 8. All county, state, and federal parks within Tillamook County remain closed.
 9. All other county parking lots, beach accesses, and certain parking areas along road rights-of-way remain closed.
 10. This resolution in the matter of opening certain Tillamook County boat launches shall remain in effect unless otherwise amended by the Board.
