I wish to serve because as a lifelong resident, Tillamook alumnus, and TSD#9 parent, I am deeply invested in our community. My philosophy is that every child deserves to have the best education and opportunities possible. I have attended almost every school board meeting for the last year and a half and have studied district policies to be better informed. I would enjoy being part of a thoughtful, productive team that further contributes to student, staff, and community success.
